Introduction

We have audited whether the Board of Directors and the Chief Executive Officer of Catena AB (publ.) have complied with the guidelines for remuneration to Group Executive Management during the financial year 2009 which were approved by the Annual Meeting of the Shareholders held on 29 April 2009.
